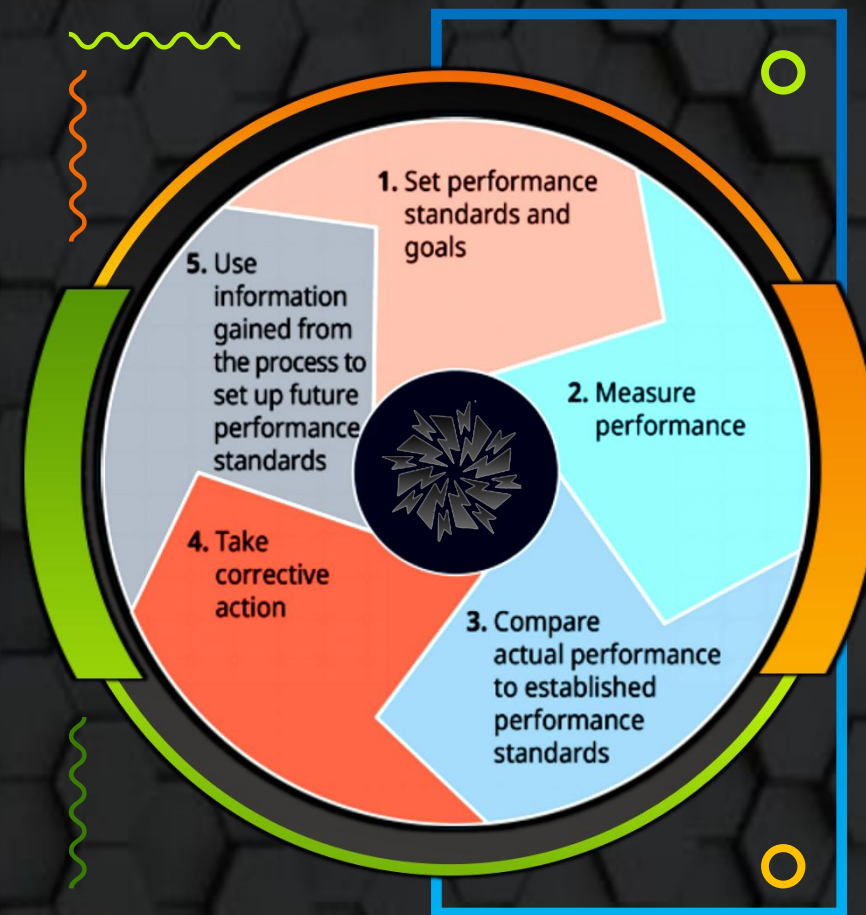

Ship Building

In order to satisfy the owners' criteria, the "THEOMNIVOLT" designers iterate their process one or more times, creating a spherical loop known as the design spiral. It's a methodical loop with the multiple steps. The Objective is focused on the kind and purpose of the vessel. Further design specifications, and quantity and range dimensions are determined.

Chartering

The process of chartering a ship is complicated since several considerations need to be made before a charter is agreed upon. "THEOMNIVOLT" as a Shipbrokers plays a crucial role in matching up the appropriate shipowner and charterer and completing the details of their contract. The Three Primary Ship Charter Types - Voyage Charter, Time Charter, Bareboat Charter.

Sale & Purchase

"THEOMNIVOLT" as a shipbroker are responsible for managing the global Sale and Purchase (S&P) of both new and used offshore vessels. Depending on the inquiry, we collaborate with buyers, sellers, and other S&P Shipbrokers. Buyers may request copies of the primary certificates and a basic inspection of the vessel before signing the Memorandum Of Agreement.

STS Operation

"THEOMNIVOLT" is specialized in Ship To Ship (STS) so that the traffic in many terminals are avoided. STS transfer constitutes one of the most common safest operation as minimum number of pollution or other incidents, but also high-risk operations in shipping. The STS procedure can take place either while both vessels are at anchor or, in certain situations, while they are moving.

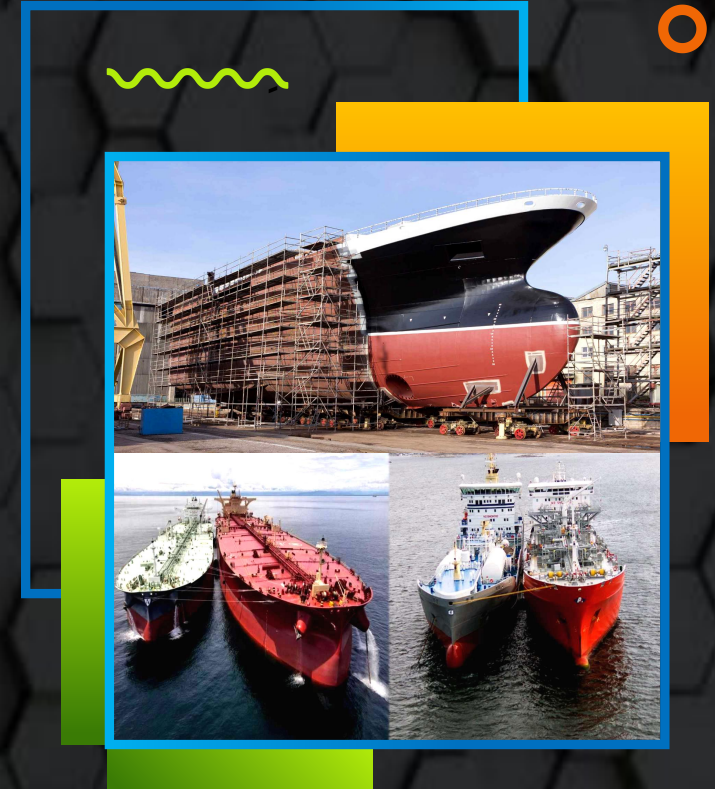
Decarbonization
